#### **Manigo Privacy Policy**

#### Introduction

MANIGO SERVICES LTD values its user's privacy. We would like to inform you about the management of your personal data in accordance with Art. 13, 14 General Data Protection Regulation (GDPR). Manigo Services Ltd is the Data Controller for the safety of your personal information. We are registered as a Data Controller with the Information Commissioners Office (ICO), registration number . ZA214276

The revised privacy policy is effective 19 November 2018 and it summarizes what information we might collect from a registered user or other visitor ("you"), what is the legal basis for collecting and what we will and will not do with it.

Please note that this privacy policy does not govern the collection and use of information by companies that MANIGO SERVICES LTD does not control, nor by individuals not employed or managed by MANIGO SERVICES LTD. If you visit a Web site that we mention or link to, be sure to review its privacy policy before providing the site with information.

#### What we do with your personally identifiable information

It is always up to you whether to disclose personally identifiable information to us, although if you elect not to do so, we reserve the right not to register you as a user or provide you with any products or services.

"*Personally identifiable information*" means information that can be used to identify you as an individual, such as, for example:

• your name, email address, phone number, address

If you do provide personally identifiable information to us, either directly or through a service provider or other business partner, we will:

- not sell or rent it to a third party without your permission although unless you opt out (see below), we may use your contact information to provide you with information we believe you need to know or may find useful, such as (for example) news about our services and products and modifications to the Terms of Service;
- take commercially reasonable precautions to protect the information from loss, misuse and unauthorized access, disclosure, alteration and destruction;
- not use or disclose the information except:
  - as necessary to provide services or products you have ordered, such as (for example) by providing it to a carrier to deliver your ManigoCard;
  - $\circ$  in other ways described in this privacy policy or to which you have otherwise consented;
  - in the aggregate with other information in such a way so that your identity cannot reasonably be determined (for example, statistical compilations);
  - o as required by law, for example, in response to a subpoena or search warrant;
  - $\circ$   $\;$  to outside auditors who have agreed to keep the information confidential;
  - as necessary to enforce the Terms of Service;

 as necessary to protect the rights, safety, or property of MANIGO SERVICES LTD, its users, or others; this may include (for example) exchanging information with other organizations for fraud protection and/or risk reduction.

#### Other information we collect

We may collect other information that cannot be readily used to identify you. We may use this information, individually or in the aggregate, for technical administration of our services; research and development; customer- and account administration; and to help us focus our marketing efforts more precisely.

#### Cookies

MANIGO SERVICES LTD uses "cookies" to store personal data on your computer. We may also link information stored on your computer in cookies with personal data about specific individuals stored on our servers. If you set up your Web browser (for example, Internet Explorer or Firefox) so that cookies are not allowed, you might not be able to use some or all of the features of our Web site(s).

#### Where we store your personal data

Information you provide when you apply or sign up for the App, go through our identity or account verification process, authenticate into your account, communicate with us, answer our questions, or otherwise use the App or the website <u>www.manigo.com</u> is stored on secured servers provided by third party hosting vendors.

The data that we collect from you may be transferred to and stored at, a destination outside the European Econonic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us or one of our suppliers. Prior to transission of your information outside the EEA, we will ensure that adequate measured are in place to ensure the security of your data which are equal to EEA standards are in accordance with this policy.

#### Your privacy responsibilities

To help protect your privacy, be sure:

- to take customary precautions to guard against "malware" (viruses, Trojan horses, bots, etc.), for example by installing and updating suitable anti-virus software.

#### Your data protection rights

In certain situations, listed in Art. 20 GDPR, you have the right to data portability. **If the data is processed pursuant to Art. 6 para. 1 s.**
